#### **General Information**

- Rural Response for Healthy Children reviews applications for consideration monthly.
- Following the review process, applicants will be notified in writing, via email, as to whether their application has been declined or approved and the number of training codes granted.
- If the application form is approved, the applicant will receive confirmation of the appropriate RiS 'Pre-Registration code(s)' to which the recipient(s) will have 60 days to complete the online course before the code expires.

### **Application Submission Procedure**

Applications accepted on an on-going basis.

The goal of this sponsorship is to encourage people to recognize Safe Places – Youth Certified as a quality standard for those who come in to contact with youth. The preferences outlined below may apply to the review process.

- Favorable consideration may be given to volunteer-based or non-profit organizations.
- Favorable consideration may be given to individuals, or charitable non-profits that include a financial contribution towards the training themselves from their own operating budget or fundraising efforts.

### Eligibility

Any individual volunteers or non-profit charity organizations who provide programs or services for children and youth in Huron County are encouraged to apply if they do not have funds available to pay for their Certification.

Requirements

- 1. The applicants must provide a service or directly deliver programs in the community of Huron County to children and youth with the intent to become Safe Places Youth Certified.
- 2. Recipients of sponsored training will have 60 days from the date of the confirmation letter to complete the RiS course before the training expires.
